Master Use Permit to subdivide one parcel into six parcels of land.

This land on South Director Street is accessible over below-standard streets which are only 20 feet wide.

- * To the west, Director Street is 20 feet wide and connects to 46th Avenue South which is 30 feet wide.
- * To the north, 48th Avenue South is 20 feet wide where it connects to South Henderson Street.
- * To the east Director Street is 20 feet wide to 50th Avenue South.

These streets are completely inadequate for this proposed subdivision.

There probably will be more cars than can be parked at the on-site parking spaces. The excess will park in dirt and mud along the narrow unimproved streets.

Fire trucks will have difficulty in being positioned at potential fire scenes, thus delaying essential emergency services. This problem became apparent in the disasterous Villa Plaza Apartment fire on September 21, 1991. This lies on the east side of the 20 foot wide 48th. Avenue South and south of the 20 foot wide South Director Street. These below standard right-of-ways certainly contributed to the great property loss of that event.

This parcel, among others, was studied in the Southeast Seattle Multifamily remapping process, Case # 16, and described in these two documents:

- * "Office of Long-Range Planning, November 1991."
- * "Mayor's Multifamily Remapping Recommendation April 1992."

These documents state that according to the 1984 Seattle Comprehensive Transportation Program these streets do not meet the standards of right-of-way and paved widths: South Director Street, 46th and 48th Avenues south of South Henderson Street.

Now is the time to correct these narrow street problems. We request that no subdivisions or other land use actions be approved along South Director Street between 46th and 50th Avenues South until adequate right-of-way is constructed to South Henderson Street providing sidewalks, adequate surface water management, and full time two way traffic lanes.

Norm Sargent reviewed incoming bulletins, notices etc. Jo Simone had a letter from the Seattle City Council member who attended the February 7, 1998 breakfast..

Various land use items were discussed. This included a six parcel subdivision at 3..Director St. and 48th Ave. 3.. Joe Marley presented a proposed letter requesting that this not be approved until satisfactory access streets and adequate surface water management can be provided.. Present streets are only 20 feet wide. This letter was approved by motion.

Discussion and passed motion: The Club will donate \$ 500 to Kubota Garden Foundation as a memorial to Howard Wilson.

Norm Sargent discussed possible rentals of the Clubhouse.. Presently our policy is that a Board member agrees to be 100% responsible for any group using the Club house. We need to prepare a formal policy.

Norm Sargent suggested that the Club establish committees for social, government, and community development.. Also, subjects for another general meeting were discussed..

The Church would like to rent the Clubhouse for an event of 5 or 6 days duration. Presently we charge them \$ 50 per day above their regular monthly use..

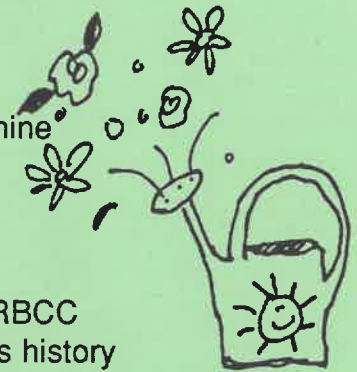

General Meeting April 4, 1998

Presiding: President Norm Sargent Held at Clubhouse

President Sargent introduced Mayor Paul and Pam Schell. The Mayor spoke briefly and answered questions from the audience.

Bob Ridder spoke on the Brighton Place Apartments and the creation of a Foundation to finance purchase of the structure. This would be used for senior citizen retirement living.

Discussion of the rezone application at 9050 Seward Park Ave. S.: NC 2 30'/OM to NC 2 30'/UR. This will allow view (of the Lake) blocking residential structures. It was moved, seconded, and passed: the Club will request the Hearing Examiner to withhold the decision on this rezone until the Rainier Beach Neighborhood 2014 Planning Committee can prepare recommendations for our Rainier Beach neighborhood.

Famely Green of the Southeast Seattle Service Center described the activities in Rainier Valley, the RTA, programs, and City services.

Joe Marley was elected temporary Chair in the absence of President Norm Sargent. Minutes of the March 24, 1998 Board Meeting were read and approved. Norm McAdory presented and discussed the financial report which was approved by the group.

Mike McCarty reported the VFW had no heat in the basement. Glendale Oil replaced the basement thermostat which had a burned wire. Mike described his test of pouring blue dye into the southwest basement entrance drain. None appeared at any place on the interior basement floor. This indicates that the drain is not responsible for basement floor flooding. It was concluded that Norm Sargent is studying further possible actions. Mike described the VFW items hindering our use of the storage room next to the furnace. These should be removed so that we can easily access our shelves and cupboards. Norm McAdory agreed to look into this with the VFW.

The rezone at 9050 Seward Park Ave. S. to allow residential structures which will block the public's view of Lake Washington will be before the Hearing Examiner at 9 A.M. Thursday April 30, 1998. To continue neighborhood planning, Joe Marley will draft a letter to the Rainier Beach Neighborhood 2014 Planning Committee requesting that its members join our Club..

Mike McCarty reported that the neighbor to west of Clubhouse has constructed a fence approximately five feet into the public alley. Joe Marley will get costs of surveying our lot. The City has previously verbally told Mike McCarty that this would be needed to determine our lot lines.

Land use report: Proposed rezone at 8457 Rainier Ave. S. (Choverdale St.) from L3 and SF 5000 to NC 2 - 40 ft.

Norm Sargent reported on a proposed traffic circle at 57th Ave. S and S. Fletcher St. He also covered other incoming info to the club.

The group discussed a name for the new auditorium at Rainier Beach High School as requested by our District school member Jan Kumasaka. It was moved, seconded, and passed that the name Marie Wilson be submitted. Jo Simone will so notify Jan Kumasaka.

Norm McAdory reported that the VFW and Church signs of our renters have been vandalized with spray paint etc.

Norm Sargent discussed a request from Jonathon Jackson, RTA staff, that we prepare an opinion on the rail transit. The group discussed an underground rail station at S. Henderson St and 50th Ave. S. It was moved, seconded, and passed to support the recommendation of RBN 2014 for a study of a rail transit tunnel with a station at S. Henderson St and near Rainier Ave. S.
